Office Order No. 68 of 2024

Please refer to ESIC headquarters Office Orders No. 27, 28 & 29 of 2024 dated 01-03-2024 (AGT-2024), wherein grievances, if any were invited from the concerned medical Officers. The Grievance Redressal Committee (GRC) was constituted under the provisions of Clause 12 of the Transfer Policy dated 20-06-2022 for clinical postings and the Policy dated 30-05-2024 for administrative postings.

The GRC meticulously examined the grievances and addressed them in their report (GRC Report enclosed).

The Competent Authority has approved the recommendations of GRC. Based on the recommendations of the GRC the controlling officers (MS/Dean/RD as applicable) are directed to follow the instructions mentioned in the Annexure I.

GRC recommended some of the cases for review at the level of Medical Administration Branch. In this connection, Medical Administration has reviewed the cases and directions have been given vide Annexure-I.

Further, it is also informed that Grievances in r/o Dr. Sujesh Kumar, CMO, Empl.ID 115642 and Dr. Raichur Vijay Kumar, Emp.ID 150994 are under examination and the decision will be communicated later as per the approval of competent authority.

In some of the cases, the medical Officers have pursued legal action regarding their transfers and the Hon'ble courts have given directions to the applicant and the respondent (ESIC). In such cases, the controlling officers (MS/Dean/RD as applicable) are directed to deal individual cases, which are sub-judice, as per directions of Hon'ble court/CAT.

Note:

1. All Controlling authorities (MS/RD/Dean as applicable) to ensure that a copy of this order is promptly issued to all concerned Medical Officers.
2. The controlling authority may please ignore these orders in r/o medical officers who have left the organization on account of VRS, Superannuation and Resignation.
3. The Medical Officers who have already joined the newly ordered place of postings as per transfer order dated 01-03-2024 in AGT 2024, may please ignore this order. Their joining at new place of posting shall be treated as final and the above recommendations in such cases shall be ignored.
4. Discrepancy, if any, noted by the controlling authority in respect of medical officers who pursued legal action regarding transfers may please be informed to ESIC Headquarters immediately for further directions.
