Sub: Submission of life Certificate- Payment of Pension/Family Pension - Reg. \*\*\*\*\*\*\*\*\*s

As per Instructions, ESIC Pensioners/Family pensioners, who are attaining 80 years and above, are required to submit life certificate in prescribed Proforma **to this office from 1<sup>st</sup> October to 31<sup>st</sup> December, each year, either in person or through ESIC Branch office or through post with due attestation.** As such, all the pensioners and family pensioners drawing pension/family pension through Regional Office, Chennai (PDA), are required to submit life certificate during the period from **1<sup>st</sup> October 2020 to 31<sup>st</sup> December 2020**, to arrange timely/uninterrupted disbursement of pension/family Pension.

Life certificate may be obtained from any of the authorities specified hereunder and is to be dated not earlier than the 1<sup>st</sup>, October 2020.

- 1. Officer of ESIC Regional Office/Sub Regional Office/Branch Offices/Dispensary Cum Branch Office.
- 2. A Person exercising the powers of a Magistrate under Criminal Code.
- 3. A Registrar or Sub Registrar appointed under Indian Registrations Act.
- 4. A Gazetted Govt. Servant
- 5. A Police Officer not below the rank of Sub Inspector in charge of a Police Station.
- 6. A Post Master, a departmental sub posts Master or an Inspector of Post Offices.
- 7. A Class I Officer of the Reserve Bank of India, an Officer (including grade II Officer) of the Public Sector Bank;
- 8. A Pensioned Officer, who before retirement, exercised the powers of a Magistrate;
- 9. A Justice of peace;
- 10. A Block Development Officer. Munsif, Tehsildar, or Naib Tehsildar;
- 11. A Head of a Village Panchayat, Gram Panchayat, Gaon Panchayat or an Executive Committee of a Village;
- 12. Members of Parliament of State Legislatures or of legislatures of Union Territory Governments/Administrations.
- 13. Treasury Officer.

Further, if the pensioner / family pensioner is unable to obtain life certificate due to illness / incapacitation etc., an intimation to this effect supported by a Medical Certificate from a Registered Medical Practitioner about his inability to appear in person should be sent to this office so that this office will nominate an officer to visit the pensioner at his/her residence/hospital for the purpose of recording life certificate.
