## **INFORMATION REGARDING ATAL BEEMIT VYAKTI KALYAN YOJANA SCHEME**

It is hereby informed that the ESIC Corporation has decided to extend the scheme ABVKY for another one year period from 01.07.2020 to 30.06.2021 and also to relax the eligibility conditions in the scheme for the period 24.03.2020 to 31.12.2020 in order to provide benefit to the IPs who became unemployed due to COVID-19 induced lockdown. The relaxation in the eligibility condition is as under:

| 1    | IP should have been in Insurable employment for a minimum period of 2 years immediately before his/her unemployment and should have contributed for at least 78 days during each of preceding 4 contribution periods. | IP should have been in Insurable employment for a minimum period of 2 years immediately before his/her unemployment and should have contributed for not less than 78 days in the contribution period immediately preceding to unemployment and minimum 78 days in one of the remaining 3 contribution periods in 2 years prior to unemployment. |
| 2    | Relief becomes payable 90 days after unemployment   | Relief shall become due for payment 30 days from the date of unemployment   |
| 3    | IP's claim for relief under the scheme is to be forwarded by the last employer of IP  | IP's claim need not be forwarded by the employer. The claim may be submitted directly in Branch Office and the verification of the claim with the employer will be done at the Branch office level. Aadhar card shall be used for identification of IP  |
| 4    | Relief to the extent of 25% of average per day earning during the previous 4 contribution periods to be paid upto maximum of 90 days of unemployment.   | Relief to the extent of 50% of the average per day earning during the previous 4 contribution periods to be paid upto maximum of 90 days of unemployment.   |

The Scheme will be available with original eligibility conditions as per instructions from Headquarters issued in P-11/14/11/ABVKY/2018 dated 14.12.2018 for IPs who became unemployed on or before 23.03.2020 and on or after 01.01.2021.
